2024 MEDICARE NUMBERS

The Centers for Medicare and Medicaid Services (CMS) has released the new Medicare premiums, deductibles, and co-payments for 2024:

Standard Part B Premium.....	\$174.70/mo*
Part B annual deductible.....	\$240
Part A deductible per benefit period....	\$1,632
Co-payment for hospital stay	
Days 61-90.....	\$408/day
Days 91-150.....	\$816/day
(Full costs for each day beyond 150 days)	
Skilled nursing facility co-payment	
Days 21-100.....	\$204

*Note that individuals with annual incomes over \$103,000 and married couples with annual incomes over \$206,000 will pay a higher Medicare Part B Premium, with a monthly premium of \$244.60.

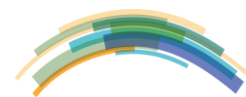
